REGISTRATION EXERCISE AY2023/2024

The Registration Exercise for all Science & Pharmacy freshmen will be held in 2 parts and both parts are compulsory. You should have received an email from the Registrar's Office (RO) detailing the registration procedures by now. Registration (Part One)

All freshmen regardless of citizenship should have completed registration (Part One) and obtained their Student ID, PIN, NUSNET ID & NUSNET Password by now. These are personal and confidential information which should not be shared with anyone else. You will need to use the NUSNET ID and NUSNET password to access the various online systems in NUS. Freshmen under the age of 18 years at the point of completion of registration (Part One) may refer to the Registration Guide for other instructions.

Registration (Part Two)

Students are advised to read the Registration Guide for detailed instructions on this process. Briefly, the Part Two registration process will differ according to the freshmen's age and citizenship as follows:

- Singapore Citizens & Permanent Residents with valid Singapore mailing address
The student card will be delivered by post to your Singapore mailing address declared at the point of admission.
- International Students and Singaporeans without Singapore mailing address.
You will be informed by email on the collection of your student card in person.

Please activate your student card via the NUS [Education Records System](#) when you have collected your Student Card so that you can access the Academic Plan Declaration within the NUS Education Records System to declare your major(s)/minor(s).

STUDENT'S PASS REQUIREMENTS FOR INTERNATIONAL STUDENTS

It is the University's requirement that every full-time international student must have a valid Student's Pass (STP) when term starts. If they do not have a valid student's pass by the stipulated deadline, a warning letter will be issued. Failure to comply with the instructions in the warning letter will lead to termination of their candidature. PRE-ADMISSION MEDICAL EXAMINATION (PAME)

It is the University's policy that as an admission condition, all incoming students (excluding non-graduating students and continuing & professional education students) are required to undergo a medical examination. Please refer to <https://www.nus.edu.sg/registrar/academic-activities/registration/administrative-matters> > Medical Examination).

A Negative Service Indicator (NSI) will be imposed if students do not complete the PAME. The NSI has the following effect:

- Unable to view exam results / enroll for any courses
- Unable to obtain official / unofficial result transcripts
- Student status / conferment letter will be withheld
- Degree scroll will be withheld

The Pre-Admission Medical Examination (PAME) is considered incomplete:

- a. If the student has not undergone the PAME.
- b. The student has completed the PAME but did not submit the completed PAME form
- c. The student has completed the PAME but have outstanding tests/ the test result is unsatisfactory. This tends to be outstanding urine tests which the student could close the loop by going back to the clinic to complete the tests, or submit the outstanding medical report from specialist.
- d. Students have submitted a medical report (e.g. health screening medical report) that does not meet the University's medical examination requirements. Student can close the loop by submitting the needful report as required by UHC.

Students can complete the PAME via these options:

- a. Walk-in to UHC on Tue, Wed, Thu (8.30am to 10.30am, 1.30pm to 3.30pm);
- b. Outside clinic whereby they would be required to submit the completed PAME form to UHC.
- c. International students - They can do the PAME at the clinics in their home countries and submit the forms to UHC.

ACADEMIC PLAN APPLICATION AND DECLARATION

Academic Plan **Declaration** allows you to declare your major, specialisations, second majors (open), and minors (open) during the main semesters. Please note that you will not be allowed to register for courses unless the Academic Plan has been declared. You are also only allowed to make one declaration per semester. The minimum requirement of your candidature is to read 1 Major Programme and the maximum allowance is 2 Major Programmes with 2 Minor Programmes (Pharmacy students are allowed to read a maximum of 1 Major Programme only). Do select the Programmes according to your ability. No amendment is allowed beyond the fifth semester of study. Academic Plan **Application**, on the other hand, involves the application for closed and restricted minors and second majors. The application period is in April, for Semester 1, and October, for Semester 2. Please look out for the email sent by the Registrar's Office on Academic Plan Application.

Note: Students are required to submit your major/minor declaration in the Academic Plan Declaration system BEFORE you are allowed to access CourseReg (Course Registration). *Only **one** attempt is allowed per semester, and no changes are allowed after the declaration is submitted.

* This is applicable to all students. **A gateway course will be pre-allocated to each student according to your declared major. If you would like to be pre-allocated with the gateway course, please declare your major via the Academic Plan Declaration by 12:00hrs, 21 July 2023.** Students who miss the deadline can register for the gateway course of their choice during round 1 of CourseReg. If you do not wish to be pre-allocated with the gateway course, please complete your Academic Plan Declaration by **08:59hrs, 25 July 2023** for a smooth user experience when doing CourseReg which starts on **26 July 2023**. You **will not** be able to proceed with CourseReg unless you have done Academic Plan Declaration **at least 24 hours** before.

*For students who are intending to major in Mathematics, you will be pre-allocated with MA1100. You may drop MA1100 and select MA1100T during CourseReg itself if you wish to read MA1100T instead. Please refer to <https://www.math.nus.edu.sg/undergraduates/spm/> for more information.

Please note that students with a declared major will be given a higher priority in the selection of major courses.

Course Registration at Education Records System (CourseReg@EduRec) is the University's consolidated course registration platform. The schedule for CourseReg@EduRec for AY2023/2024 Semester 1 is as follows:

Select Courses Rounds

Do note that Rounds 0 and 1 are the protected rounds, where students will be able to select courses that can be used towards:

- Programme (CHS Common Curriculum, Major, Specialisation) requirements
- Second Major requirements
- Direct admission/ Restricted Minor requirements
- Prescribed English requirements (i.e. courses offered by CELC)

Round 2 and Round 3 are open rounds where students are able to select all courses (including General Education courses) they wish to read for the semester.

Workload

All Single Degree students can select up to a maximum of 23 Units from Select Courses Round 0 to Round 2. From Round 3 onwards, the workload allowance shall be in accordance with the student's GPA.

For freshmen, all Single Degree students can select up to a maximum of 23 Units while Double Degree students and students involved in Special Programmes can select up to a maximum of 27 Units in their first semester. Students may only apply to read beyond the maximum workload allowed from their second semester of study onwards by application during the CourseReg period.

Do note that the stipulated **minimum workload** that each student should have is **18 Units per semester**. Students are only allowed to underload in their graduating semester, or if they are doing credit-bearing internship.

COURSE AND EXAMINATION TIMETABLE

The onus is on the student to map out the study plan and avoid registering for courses with clashes in class or examination timetable. **Faculty of Science is not supportive of timetable clash waivers.** Appeals are only considered if students require the course to fulfil their graduation requirement in their graduating semester, without which might lead to a delay in graduation. NUS DATA PROTECTION POLICY AND PERSONAL DATA PROTECTION ACT (PDPA) GUIDELINES

Recently, Singapore has seen multiple cases of data breaches and attacks on our IT infrastructure. Understanding that the University is not immune to these incidents and threats, we have taken direction from the Singapore Personal Data Protection Commission (PDPC) to roll out an e-training course DP1001 NUS Data Protection Policy and Personal Data Protection Act (PDPA) Guidelines to all undergraduates.

All students are required to complete the e-training course, "E-Training Package on Student Essentials" via [Canvas](#).

QUALIFYING ENGLISH TEST (QET)

All incoming Faculty of Science students (both local and international) would have been informed by the Registrar's Office to take their QET during the 1st Round. Students will be notified by the Centre for English Language Communications (CELC) of their QET results.

- Students who obtain Band 1 will have to take ES1000 followed by ES1103.
- Students who obtain Band 2 will have to take ES1103.
- Students who obtain Band 3 are exempted from these English courses.

Students are strongly advised to complete the required course(s) within the first year of study. Students who are required to read both ES1000 and ES1103 may read ES1000 in the first semester of study and ES1103 in the second semester of study. COMPULSORY COMMUNICATION COURSE

The Centre for English Learning and Communication (CELC) and Faculty of Science co-developed SP1541 Exploring Science Communication through Popular Science, a compulsory course subsumed under the Writing pillar of the CHS Common Curriculum (see next section) for all Science students (except Environmental Studies students, NUSC and SPS students and students from any Residential Colleges) matriculated in AY2015/16 and beyond. Students are strongly advised to complete the course within the first year of study. Students who are required to read ES1000 and/or ES1103 should complete reading SP1541 within the first two years of study.

CHS COMMON CURRICULUM

The CHS Common Curriculum is designed to impart essential foundational skills and broaden intellectual foundations. Students reading a major under CHS will need to read the CHS Common Curriculum as part of their graduation requirements. The common curriculum consists of 13 courses:

**SP2271, SP2273 and SP2274 are open to all CHS students and fulfils the respective CHS Common Curriculum pillars. These courses are mandatory for those in the Special Programme in Science.*

Students are strongly encouraged to complete all CHS Common Curriculum courses within the **first 2 years** of their candidature, except for the following three courses:

- Communities and Engagement – can be taken in their 2nd year onwards.
- Two interdisciplinary courses – can be taken in their 3rd or 4th year.

CHS Common Curriculum Course Pre-Allocation

Several courses of the CHS Common Curriculum will be pre-allocated to students across their first two semesters, depending on their major. More information on the pre-allocation plans for the respective majors can be found on the FoS website [here](#).

Students who are enrolled in and have read courses from the NUS College (NUSC), University Town College Programme (UTCP), Ridge View Residential College Programme (RVRC) or Special Programme in Science (SPS) may be able to map to some of the 13 courses of the CHS Common Curriculum. Students are required to read the remaining outstanding course(s). More information can be found on the FoS website [here](#).

GENERAL EDUCATION (GE) CURRICULUM

Students admitted from AY2021/22 onwards (except students from Law, Medicine, Dentistry) will experience a new curriculum introduced by the GE Reform, which aims to ensure that the GE curriculum continues to provide a unique and relevant learning experience for students to thrive in today's rapidly-changing world. The new curriculum features the following six pillars:

- i. Cultures and Connections
- ii. Critique and Expression
- iii. Data Literacy
- iv. Digital Literacy
- v. Singapore Studies
- vi. Communities and Engagement

Students are required to read one course from each pillar to fulfil their GE requirements. These 6 pillars are embedded within the CHS Common Curriculum, hence CHS students will satisfy the GE requirements upon completion of the CHS Common Curriculum.

The CHS Common Curriculum that are mapped to the respective GE pillars are as follows:

For each Major, up to 8 Units may be used to meet (i) the Major requirement and (ii) the General Education or College (e.g., Common Curriculum) requirement.

DEGREE REQUIREMENTS

Minimum Unit Requirements

- i. At least 160 Units in total
- ii. Minimum Units that must be earned from NUS courses

- iii. At most 60 Units of Level-1000 courses; any excess does not count towards the total Units graduation requirements. The following courses do not count toward the 60 Units limit:
 - a. CFG1010
 - b. CFG1002 (AY16/17 enrolment onward)
 - c. Courses under the Design-Your-Own-Course (DYOC) initiative
 - d. ES1103
 - e. Polytechnic UEM APCs
 - f. HS1301 (AY21/22 enrolment onward)

Second Majors, Minors and Specialisations

- i. Second Major

A Second Major programme is conceived as an opportunity for students to broaden their knowledge and capacities by pursuing a second Major alongside their primary Major. The Second Major affords a significant degree of depth, although its Units requirement is set below that of the Major. The Second Major is a non-Honours major.

The Unit requirement for a Second Major is at least 40 Units, of which:

- Up to 16 Units (40% of the Unit requirements for a Second Major) may be used to meet (i) the Second Major requirement and (ii) another requirement, e.g., General Education, College, Faculty requirement outside CHS, Major, Second Major, Minor, Specialisation or other requirement.
- At least 12 Units must be at Level 3000 and above.
- A minimum of 60% of the Second Major requirements must be earned from courses read at NUS. Courses read at NUS include all courses taught, co-taught, supervised or co-supervised by NUS faculty member(s). These consist of graded courses or courses with an 'S' or 'CS' grade. The remaining Units may be earned through credit transfers, advanced placement and exemptions, from courses deemed relevant to the particular Second Major.

- ii. Minor

A Minor programme is a coherent course of study in an additional area outside of the Major. By doing this, it contributes to the breadth of learning envisaged for undergraduate education.

The Unit requirement for a Minor is at least 20 Units, of which:

- Up to 8 Units (40% of the Unit requirements for a Minor) may be used to meet (i) the Minor requirement and (ii) another requirement, e.g., General Education, College, Faculty requirement outside CHS, Major, Second Major, Minor, Specialisation or other requirement.
- At least 12 Units for any Minor must be taken from outside the entire set of courses that are listed for the major(s)/another minor that the student is taking/ has taken.
- A minimum of 60% of the Minor requirements must be earned from courses read at NUS. Courses read at NUS include all courses taught, co-taught, supervised or co-

supervised by NUS faculty member(s). These consist of graded courses or courses with an 'S' or 'CS' grade. The remaining Units may be earned through credit transfers, advanced placement and exemptions, from courses deemed relevant to the particular Minor.

iii. Specialisation

A Specialisation is a programme of study on a particular specialised sub-discipline of a higher level within its main discipline.

The Unit requirement for a Specialisation is at least 20 Units of higher-level courses of a specialised nature within a Major. Up to 8 Units (40% of the Unit requirements for a Specialisation) may be used to meet (i) the Specialisation requirement and (ii) another requirement, e.g., General Education, Major, Second Major, Minor, Specialisation or other requirement.

Double Counting policy

- i. Ensure that you do not violate double counting policy:
 - a. For major-major, major-minor, minor-minor and specialisation-other requirement.
 - b. No triple counting is allowed i.e. you are not allowed to use one course to satisfy:
 1. 2 majors + 1 minor
 2. 1 major + 2 minor
 3. 3 minors
 4. specialisation with 2 other requirements (for Cohort AY2021/22 onwards)

Even with double counting, Units will only be counted once toward the minimum Unit graduation requirements.

With the flexibility of the CHS curriculum, you can chart your own education pathway depending on your interests, aptitude and career aspirations. You can choose to be a versatilist, integrator or deep specialist. Please also note that My Graduation Audit Report & My What-If Report do not take into account the courses you have not completed and passed. These two reports act as guides to assist you with graduation checks.

The onus is on the student to check their fulfillment of Graduation Requirements based on these two reports. You are strongly advised to refer to the graduation requirements available on the Faculty of Science website and the Bulletin based on your cohort.

S/U OPTION ENTITLEMENT

With the launch of Enhanced Grade-free Scheme with effect from AY2016/17 Semester 1, students may exercise the S/U option for up to 32 Units in the first year, including the first two regular semesters and first year special term. If this is not fully utilized, the S/U option may be exercised in subsequent semesters, for up to 12 Units.

Variations on the limit of S/U options that can be exercised apply for specific groups of students:

- i. Students without prior university experience but are granted 20 or more Advanced Placement Credits (APCs) at the point of admission to NUS may exercise the S/U option for up to 20 Units in the first two regular semesters; if this is not fully utilised, the S/U option may still be exercised in subsequent semesters, for up to 12 Units.
- ii. Students with some prior university experience (which are being recognised towards the NUS degree) may exercise the S/U option for up to 12 Units anytime during their candidature, including the first year.
- iii. Students with a prior university degree are not eligible for the grade-free scheme.

Key Points to Note

- Both the 'S' and 'U' grade count towards the total S/U Option entitlement.
- For courses read on an S/U basis, the Units are obtained only if a student attains a Satisfactory 'S' grade for the course.
- All courses read on S/U basis are excluded from the computation of the GPA.
- S/U option, once exercised, is irrevocable. Students may not later request for a conversion to a letter grade.

CONTINUATION, PROBATION AND DISMISSAL

To remain in good academic standing, and to continue in an undergraduate programme of study, a student may not have GPA below 2.00 for two consecutive semesters. For any semester in which the student's GPA falls below 2.00, s/he will be placed on probation. If the student's GPA remains below 2.00 for the second consecutive semester, the student will be issued a letter of dismissal by the Registrar's Office and denied re-admission. The student may appeal against the dismissal if there are extenuating circumstances. However, each student is only allowed to appeal **once** during his/her candidature.

With the launch of Enhanced Grade-free Scheme:

- For students eligible to exercise ≥ 20 Units of S/U options, the above continuation rules are applied from the third semester onwards.
- For students eligible to exercise ≤ 12 Units of S/U options, the above continuation rules are applied from the first semester onwards.

Students who face difficulties in coping with their studies are encouraged to approach their academic mentors for guidance and support. The respective mentors will be able to guide and advise students of the various avenues where help is available. FEE POLICIES

Tuition Fee Beyond Normal Candidature

With effect from the admission cohort of AY2016/2017, students admitted into an undergraduate degree under the modular system in NUS and who take longer than the normal candidature period to complete their degree requirements will have to pay partial non-subsidized fees, culminating in full non-subsidized fees, during the extended semesters.

In view that the Ministry of Education provides a Tuition Grant to subsidize a student's tuition fees up to the normal candidature period, the tuition fee payable beyond that would be the full non-subsidized semestral fees. To mitigate the impact of higher fees, the University undertakes to charge affected students only a proportion of the full non-subsidized semestral fees pro-rated based on the Units read in the extended semesters. In addition, the pro-rated full fees payable in the first and second semester beyond normal candidature will be capped at 120% and 150% of the subsidized semestral fees respectively.

The fees payable beyond normal candidature period are summarized in the following table:

Students who register for course(s) in the Special Term immediately following the expiry of their normal candidature period will continue to pay subsidised fees on a per course basis. However, for the Special Terms beyond that, the Special Term fees payable will be the full non-subsidised semestral fees pro-rated based on the number of Units read.
